Successful Story of a Young Urban Planner

When I was young I wished to become a lawyer and be the first Burgher lawyer from Valaichchenai. The style of debate, the types of jokes (double pun) narrated by my father's lawyer friend fascinated me and stirred my teenage ambition. Yet my life's young journey led me to different paths. Today I am a qualified Urban Planner from Moratuwa University (2012) and working for UN Habitat as an Urban Planning Officer. A few months ago I was also elected President of the All Ceylon Young Planners Forum (2014-2015).

Today I write to share with you my story with the objective of thanking my donors and to inspire our young Burghers to take the path of achieving their goals.

Firstly, my thanks go to Ms Anne Keegal, of the 80 Club in Melbourne, who sponsored me during my final year of undergraduate study. This was a time when my Rs15,000 (minimum) per month Colombo living costs was adding up to be a burden on my family. Thus I approached the Burgher Union to see if they could help me get sponsorship. This they did through the 80 Club in Melbourne and my sponsor also shared in my good times, by so kindly sending me a congratulatory present for my graduation. To another generous donor from Australia who wishes to be anonymous my grateful thanks for gifting me a brand new laptop which was invaluable for my GIS (Geographic Information Systems) subjects and allowed me to do my regular Saturday presentations, which was a mandatory undergraduate requirement.

To inspire our young Burghers, let me now share with you my story of my studies in the sequence it occurred, with its ups and downs!

My journey of study started at my local school in Valaichchenai. When I reached Grade 9, due to the war and my family's financial conditions, the decision was taken to board my brother and me at Kalmunai Carmel Fatima College. Being in boarding school meant we had no opportunities for tuition. It was thus up to us to revise what we learnt at class and do whatever homework was set at class. Everyday there was an allocated time set for us to study, play and pray. This was a structured lifestyle and I learnt to benefit from it.

Having put in the hard work of revision, doing well at my class tests, and doing the past examination papers, added up to the expectation that I would achieve 10 A's at my O/Level exams which I undertook in 2004.

Returning to boarding/Hostel school in January 2005 was a difficult time for us all as it was just after the 2004 December tsunami. Many of us had lost our relatives and friends. For me it was the loss of 7 of our boarding school friends who were at College on the 26th December and around 20 of our relatives from the Dutch Bar. My life was thankfully saved, as I left for my holidays on the 24th December.

I returned to school with a heavy heart to settle into My GCE A/Level studies. Yet when I received my O/Level results I was even sadder for I achieved 5 A's 4 B's and 1 credit. Whilst to some this would be a good result, for me and my teachers this was far from our expectations. These were very difficult times and what saved me were my sports, which the Christian Brothers encouraged. Yet my studies were suffering until I finally took heed of my teachers' mounting concerns.

Somewhere in me, I realized I could use the very discipline of my sports and the structure of my boarding school life to improve my studies. I somehow had to return to the discipline of revision, as tuition classes continued to be out of my reach. Thankfully I found the rhythm to play my sport and in the evening to spend my time in revision and homework.

I began to improve and in the final months I was able to go out for A/Level tuition classes for Logic and Political Science. I didn't need tuition in Geography as there were only 3 of us in class and we had a very dedicated Geography teacher.

Once again there were high expectations for my A/Level results. I got 3 A's and was ranked 16th in the District. Yet the expectation was for me to be within the 10 top scorers. My score was too low for Law. I toyed with the idea of repeating my A/Levels. I even applied to the Banks who accepted me. Yet I declined banking feeling bank work was too much of a sedentary job.

My Geography teacher understanding my situation encouraged me to apply to Moratuwa University to undertake the newly offered degree in Urban Planning which was part of the Faculty of Architecture. This I did and was blessed to be accepted.

Being at University, in Colombo and on my own was all a new world to me. Soon I realized my study load meant I had to discipline myself much like I did with my sports and studies. It didn't always work but overall I was disciplined. I also enjoyed doing project work which during my four year undergraduate program included 1) a Housing Development Project in Kalmunai, 2) a Regional Development Project involving agriculture in Anuradhapura & Polonnaruwa, and 3) a national level project involving Sri Lanka's 103 rivers. I also earned a place in a University consulting project, for Batticaloa and Negombo which addressed Climate Resilience Action Plan for Urban Coastal Areas.

Today, these projects stand me in good stead for I am responsible for coordinating with the Urban Development Authority and the Local Authority to design a Disaster Preparedness Plan and Urban Development Plan for Mullaithivu city. These projects also let me visit Germany and co-present a paper at the 2013 Global Resilient Cities Conference. Who would have thought a boy from Valaichchenai would have taken this path!

The path we walk is helped by others - and to the Burgher Union and my donors, I offer my thanks as I do to my family, teachers and friends. To the younger generation and to their parents I hope that my story serves to inspire you.

I am proud to be the first Burgher "Urban Planner" of Sri Lanka.

Michelle de Kretser

Michelle de Kretser is an Australian novelist who was born in Sri Lanka (then Ceylon) and moved to Australia in 1972. Michelle was educated at Methodist College, Colombo. Also, she went to school in Melbourne and later to the Melbourne University and then to the Sorbonne in Paris.

Her first novel THE ROSE GROWER WAS PUBLISHED IN 1999. Her second novel THE HAMILTON CASE was published in 2003. It won the Tasmania Pacific Prize, the Encore Award (UK) and the Commonwealth Writers Prize (Southeast Asia and Pacific.) Michelle's third novel THE LOST DOG was published in 2007. It was one of 13 books on the long list for the 2008 Man Booker Prize for Fiction. It won the 2008 New South Wales Premier's Literary Award - The Christina Stead Prize for Fiction and, in the same year, it won the Book of the Year Award known as the BOTYA.

Her fourth novel QUESTIONS OF TRAVEL won the 2013 Miles Franklin Award. The Miles Franklin Award is an annual literary prize awarded to "a novel which is of the highest literary merit and presents Australian life in any of its phases."

Michelle is the daughter of Puisne Justice, Oswald Leslie de Kretser Jnr. and Sonia (Peggy) Marshall and granddaughter of Justice Oswald Leslie de Kretser Snr. CMG (Companion of the Order of St. Michael & St. George) and Ruby Irene Leah Thomasz.
