Mr Maurice, you & to all the others who are doing a fantastic job for us. May God bless you all. **Joe.**

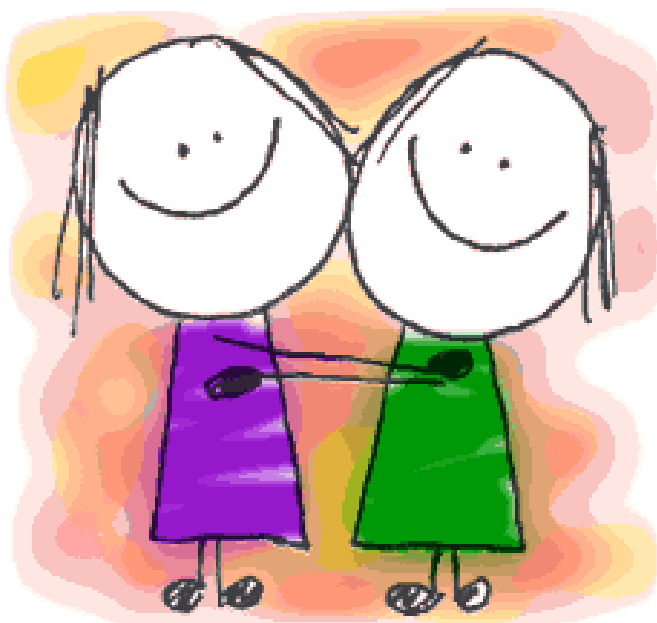

HOW YOUR MONEY IS SPENT

During the period January 2014 to April 2014, many applicants were assisted from the Emergency Fund. For instance:

Mr. P de Zilwa – Rs.2000. 66 years old and lost both legs in an accident. Wife is also paralysed after a stroke.

Mr. C. Kelaart – Rs. 1000. Returning from hospital and needed money for transport.

Mr. E. Markus – Rs. 2000. Came from Galle to bring his wife to the Colombo General Hospital.

Mrs. T. Heyn – Rs.1000. Had a fall and needed money for medication.

Mr. W. Jansz – Rs.2000. 65 years old with no job or income.

Miss. R. Gay – Rs.1000. 71 years old with no income. Lives with sister.

Miss C. De Zilwa – Rs.2000. Was sick and needed urgent medical attention.

Mr. D. Rozairo – Rs. 2000. 67 years old and no income.

Mrs. G. Wijenayake – Rs. 3000. Met with an accident and had to be admitted to hospital.

Mrs. S. Nicholas – Rs.1000. Needed money for medication.

Mrs. R. Martil – Rs.1000. Has neither family nor income. Lives with a friend.

Mrs. R. Paternott – Rs.1000. Has no family. Needed money for medication.

Mrs. V. Ludowyck – Retarded son was very ill and had been brought to hospital. Needed money for medication.

ALL WELFARE BENEFICIARIES WERE PAID A MID YEAR BONUS OF RS.3000 EACH.

Welfare Beneficiary, Mrs Sybil Bailey, passed away in May 2014 and was replaced by Mr. Shane Muspratt.

Increase in Overheads

Since the inception of the Club, we have been fortunate to be in partnership with the DBU for the distribution of funds to the Welfare Beneficiaries and Sponsored Students. However as the number of Beneficiaries and students have steadily increased it has put a greater burden on the resources of the DBU. For the past few years we have contributed \$2244 (aprox) per annum . Every 3 months they are required to write out postcards to 215 Beneficiaries and 144 Students to inform them of the date for collection of quarterly allowances. This entails hiring of chairs, organizing tea and buns, collecting cash from the bank and separating it into the various packets for payment on the due dates. We have in the past paid for security and insurance and made a contribution towards administration.

The DBU President wrote to us recently explaining that “with operational costs rising steeply and inflation in double digits, administrative costs have risen continuously”, requesting an increase in our contribution. Our Committee has agreed and the amended contribution will be approximately \$4000 per annum.

THE HUMBLING EXPERIENCE OF VISITING MY SPONSORED CHILD

In March 2014 I travelled to Sri Lanka with my church to bless the community of Batticaloa, the preschool we support and the Christian charity Y-Grow we partner with. I had not been to Sri Lanka since my teens. Before I left I contacted the club, the DBU in Sri Lanka and the little girl

I have been sponsoring Taney for 2 ½ years and knew very little about her. The aerogrammes were very sparse and I was disheartened and thought about stopping but was going to review my decision after my visit. I only really knew how old Tanya was and her birthday, her address, a picture I received when I first made contact and that her father had lost his legs in a train accident. While making arrangements I found out from the DBU that the family do not write the letters and that none of them can speak English except the grandfather. I was able to obtain a mobile phone number from the DBU and found later it belonged to Desmond the grandfather.

I visited with my friend Kate (my pastor's wife). Our tour driver (in a 15 seater minibus) was able to contact Desmond and get directions. We met Desmond and could only go part of the way because of the very narrow lanes. We took a tuk tuk further but he wouldn't go all the way because the surface of the lanes were very rocky. We walked the remaining way. Nothing prepared me for the first shock; a huge (a few stories high) open garbage mountain and the stench. The other shock was how small their place was. It wasn't much bigger than my work office and 5 children (one is an uncle), and three adults (the other is the grandfather) all live in this mini shack. It was such an honour and privilege to meet Taneya and her beautiful family and it was also a very confronting and emotional experience. Desmond interpreted for us. They wore their best clothes and were very hospitable, warm but very shy and quiet. They tried to give us some sort of drink which we had to very diplomatically and politely decline.

We took photos and I asked many questions, and gave her the presents I had for her. If I had known about her brother and sisters I would have brought more presents. We walked back to our transport with Desmond by another, shorter way (past an open sewer). We gave some money (we didn't have much on us). I left never feeling so humble and grateful to God that I am helping this family that so desperately needs it.

I am writing this to encourage others to really seriously think about child sponsorship. It has really impacted my life and I can see it has impacted this family and I am so very thankful for that.

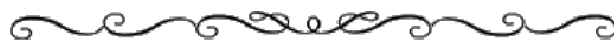
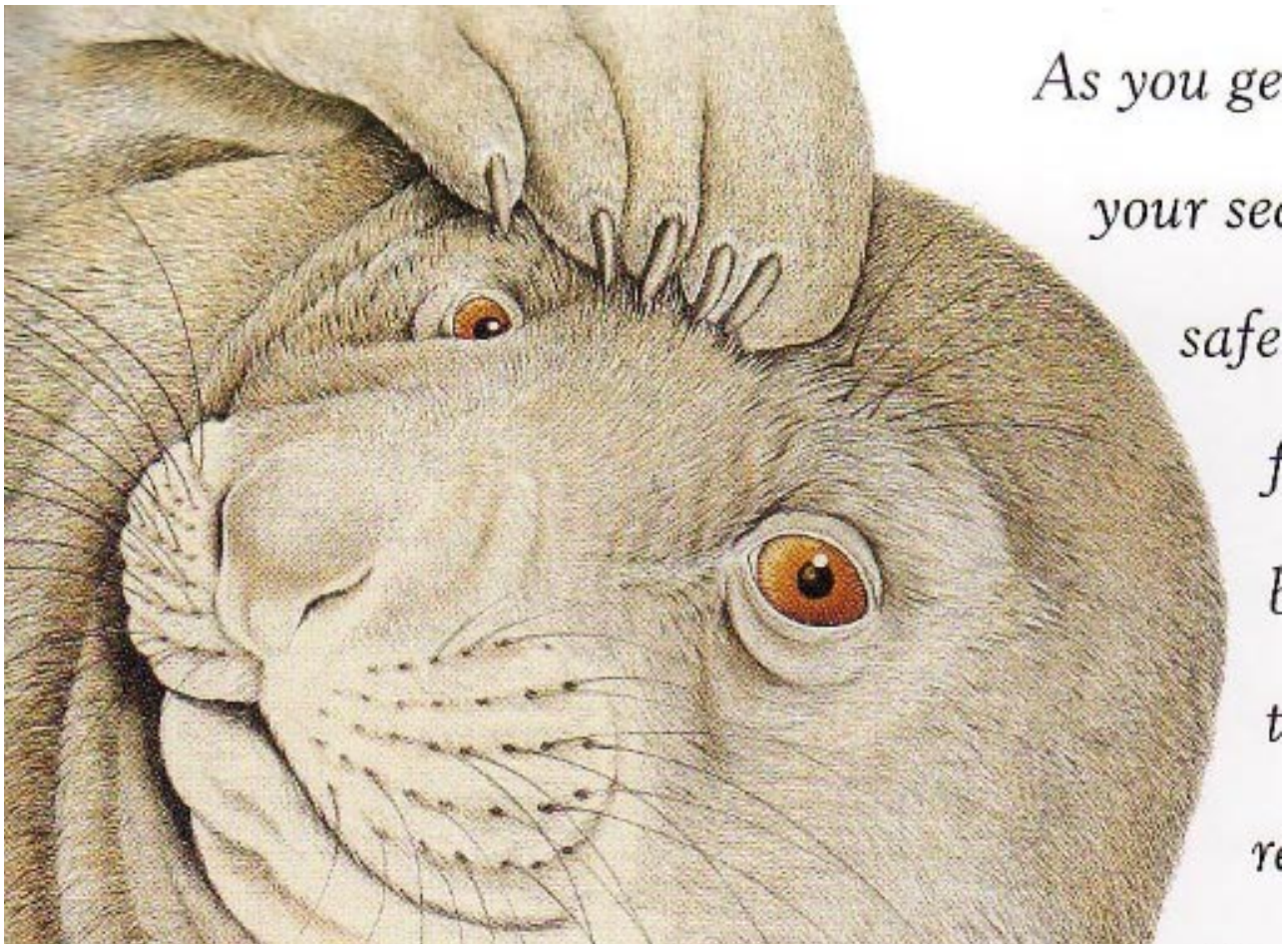
